

# BUSINESS EXPANSIONS AND TRANSITIONS

Holt County Economic Development noted 8 business expansions and assisted with 1 business transition from July 1, 2016 to June 30, 2017.

### ENTREPRENEUR TARGETING, VISITATION AND TECHNICAL ASSISTANCE

Holt County Economic Development had 195 direct interactions with Holt County businesses who requested information, referrals, or technical assistance on a variety of topics. HCED had 143 revisits to or from those initial direct interactions.

The HCED team members conducted 55 on-site business visits with targeted businesses in Holt County.

Eight requests for financial assistance / loan packaging were received from businesses and entrepreneurs that have operations in Holt County during July 1, 2016 to June 30, 2017.

# NEW RESIDENT RECRUITMENT AND RETENTION

Holt County Economic Development continues to track the new residents moving into Holt County. This past year, 85 new families began calling Holt County home.

# HEARTLAND ECONOMIC DEVELOPMENT COURSE

On April 24th, Darby attended the Heartland Economic Development Course in Blue Springs, Missouri with a scholarship that he was awarded from Black Hills Energy. This was an intense course of basic economic development taught by some of the top people in their fields. Course subjects consisted of marketing strategies, location strategies (including site selection), project funding, community development, strategic planning, workforce development, ethics, and business retention and expansion visits.

Taught in a classroom style environment there was freedom to ask questions at will. This allowed everyone the ability to tailor the class to their specific needs. Throughout the conference, they were broken down into groups with classmates from five other states and were tasked with Economic Development Challenge Labs, where teams would work together to problem solve simulated issues.

"I really found a lot of value in hearing how everyone serviced their different communities and took away some great ideas on questions to ask my own local businesses. I realized that whether my fellow students had been in economic development for 25 years or for 6 days, we were all there to learn how to do our job better. I believe that with the information I learned at Heartland, I can!"

#### BHE RENEWABLES PRESENTS \$80,000 TO HOLT COUNTY COMMUNITY FUNDS

In June of 2017, BHE Renewables contributed \$80,000 to the Nebraska Community Foundation. This donation will be distributed to the respective communitybased affiliated funds in Stuart, Atkinson, O'Neill and Chambers, as well as the Holt County Economic Development fund.

As part of the Grande Prairie Wind Project, BHE Renewables has committed to donating \$80,000 per year to benefit charitable activities and opportunities in the community surrounding the 400-megawatt energy generation project.

Alicia Knapp, project manager for BHE Renewables, stated, "when this annual donation is combined with eligible matching grants over the next five years, the fund has the potential to grow to more than half a million dollars."

The BHE Renewable contribution, along with the renewal of the Rudolph R. Elis grant, will benefit residents of all ages through a variety of projects in Holt County.
